



## **DID YOU KNOW?**

- Our doors opened on August 28, 2020 TWO WEEKS EARLY
- AJLA is 100% open, 5 days a week, 8:00am to 3:30pm IN PERSON
- During spring quarantine, we stayed connected with ALL of our AJLA families
- AJLA welcomed 27 new students for the 2020-2021 school year
- We expanded to the 2nd floor for 1st grade and opened our brand new 2nd grade
- We acquired the lower level which is used for PE and African Drumming
- We enlarged our outdoor playground for our GROWING students
- We added 3 new Orton-Gillingham trained tutors to our Academic Support Program
- Our 1st AJLA parent successfully completed his Sterile Processing Certification as a part of our **PARTNERSHIP** with Housatonic Community College
- A high-quality early childhood educational experience is directly linked to better lifetime outcome such as higher graduation rates, better health and increased self-esteem
- PARENT INVOLVEMENT in a child's education is twice as predictive of a student's success as socioeconomic status and AJLA provides an enriched parent program to all our families
- The results of our standardized testing showed both the 1st and 2nd grade class averages have jumped approximately 12 percentile points in both Language Arts and Math since last fall. This puts AJLA scholars in the 92 PERCENTILE nationally!







